## **General Information About the Baptist Student Center at The University of Tennessee**

- 1. The Baptist Student Center at 1637 W. Cumberland Avenue was purchased in 1942 for \$12,000.00 under the leadership of Dr. John Freeman, Executive Secretary of the Tennessee Baptist Convention, and Dr. Fred Brown, First Baptist Church, Knoxville. In the spring of 1962, new property was purchased at 1811 Melrose Avenue for \$50,000.00, and the old property was sold to the University for an equal amount. The TBC and Knox County Association of Baptists shared the cost of purchase and renovation. The center is owned by the Executive Board of the Tennessee Baptist Convention and is a direct part of the State Mission Program.
- 2. The first part-time director was former Knoxville Mayor, Leonard Rogers, in 1937.

The first full-time student director was Frank Grubb - 1937-1940.

In 1940, Dr. Rogers M. Smith, who later served as an administrative assistant in our Baptist Foreign Mission Board, became director. Rogers Smith later became the first State Student Director for Tennessee.

Mr. V.E. (Bob) Entrekin was the director from 1946-1949. He later served as State Student Director for Illinois.

Dr. Udell Smith was the director from 1948-1950. He finished his career in Student Ministry as the State Student Director for Louisiana.

Dr. Griffin Henderson was the director from 1950-1952. He served as pastor of Woodlawn Baptist Church, Jacksonville, Florida and was a missionary to Hong Kong.

Mr. Elbert Williams came on May 1, 1952 and left July 13, 1961. He served as citywide director in Birmingham, Alabama and was also the campus minister at Troy State University, Troy, Alabama.

Dr. Harold (Pete) Beard came in August of 1961, serving until July of 1969. He went on to become a full professor of psychology at the Central Missouri State University, Warrensburg, MO.

Rev. Bill Lee assumed duties in December 1969. He previously served as director in Memphis from 1964-69.

A position of graduate student assistant was initiated in 1967. A Southern Baptist Theological Seminary student or U.T. graduate student served an internship as the graduate assistant.

In 1971, the residence of 1815 Melrose was purchased by the Tennessee Baptist Convention and the Knox County Association of Baptists. It served as a missionary residence for a furloughing missionary family each year from 1971-1977. This person served on the staff of the BSU as international student minister and associate.

- 3. A Black Student Fellowship of the BSU was established in the spring of 1977. This is the first such organization on a predominately white campus in the country.
- 4. The first full time <u>associate</u> campus minister position in Tennessee was established in 1977 here at U.T. Dr. Bob Hall assumed the responsibilities of this position in September of 1977.
- 5. Extensive renovation of the Center took place from 1973-76. Again the cost of the project was shared by the T.B.C. and K.C.A.B.
- 6. The "Foundation of Missions" was established in 1989. This was the first campus-based student missions endowment established in the United States. The fund has experienced steady growth over its first 8 years to a \$85,000.00 level of investment. The corpus of the fund steadily increased over the years, reaching a \$250,000.00 level of investment.

- 7. The Baptist Student Center building was completely rewired and received new heating and cooling systems during 1996 and 1997. This project was completed with over 2,200 volunteer hours of labor.
- 8. During several years of the 1990's the UT-Knoxville BSU had more student mission volunteers serving through the Foreign Mission Board than any other campus in the United States.
- 9. The "Facilities Foundation" was established in 2001, the proceeds of which go to the maintenance and upkeep of the physical plant.

- 10. In 2004, alumni and ministry supporters contributed \$44,000.00 to replace all of the old windows in the building with new insulated glass windows. The replacement windows were identical in appearance to the older windows and resulted in significant utility savings.
- 11. During January 2005, the ministry was incorporated into its own nonprofit entity, Knox Area Baptist Collegiate Ministries, with its own private nonprofit designation and its own Board of Directors. The first Chairman of the Board of Directors is Dr. Bill Acuff.
- 12. A third full-time staff member, Rev. Steve Hixson, began work during the 2005-2006 academic year. Steve's responsibilities also include work on the following area campuses: Pellissippi State Technical Community College, Maryville College, and Roane State Community College at Oak Ridge. Steve is the first President of Knox Area Baptist Collegiate Ministries.
- 13. From 2007 through 2009, a major ministry center addition and remodeling took place. This \$1,500,000.00 project was accomplished for \$900,000.00. Over 300 volunteers donated time and labor to the project. Alumni, churches, foundations and the Tennessee Baptist Convention provided funds. The new building dedication was held on Saturday, August 29, 2009.
- 14. BCM Wins the 2010 ACE Cup. The ACE Cup is the annual award given by the University to the top campus organization. Our BCM is the proud recipient of this year's honor. We also received the ACE Cup in 2004. Winning this award marks the only occasion when a non-Greek organization has been so honored by The University of Tennessee.
  - In 2010 the Facilities Foundation and the Foundation of Missions were merged into one entity. The trustees serve at their pleasure on a permanent basis. Permanent trustees of the new Foundation of Missions are: Tom Butler, Jim Darlington, Joe Petre, Greg Reed and Chris Yerger. The BCM Director is an ex-officio member of this endowment board.
- 15. A new parking lot was built in 2013 at a cost of \$174,000. The lot provides north and south access points to the property. All staff members and building residents have named reserved parking spaces. The paved and graded lot also provides ministry space for outdoor programs.
